- From a current member. The costs of these privately owned shares are determined by the selling shareholder and may vary from seller to seller.
- If there are pool owned shares available, a Summer Membership may be purchased for a one time trial basis **only** at the Summer Membership price; plus any additional assessment fees for that year.
- In addition to the one- time cost of the share, members pay yearly maintenance fees that finance the operational costs of the pool. These include: chemicals, utilities, maintenance, employee wages, insurance, equipment, & property taxes.
